Subject:- Relief and resettlement measures for internal and external migrants- payment of rental allowance for hiring private accommodation for 1994-95.

Reference:- This Department Memo. No. 1/6/88- RR- 3/4597 dated 26 July, 1993.

The Governor of Punjab is pleased to extend the facility of payment of rental allowance at the rate of Rs. 300/- ( Rupees three hundred only) per month for hiring private accommodation to the internal and external migrants for 1994-95 or till their return to the original places of residence in Punjab whichever is earlier.

2. Please ensure that rental allowance does not fall in arrears as advance payment of such allowance is called for under the State policy. However, where it accrues on account of default of the Government/ its machinery, the matter may be fully scrutinised and plausible reasons offered/ recorded while allowing the payment of arrears of rental allowance to the migrants. Such an action may be reported by the concerned Sub- Divisional Officer ( C) through his Deputy Commissioner to the Director Relief and Resettlement Punjab.

3. In order to screen/ weed out the bogus cases, the following persons may not be given rental allowance:-

- a) Unauthorised occupants in the Housing Board colony.
- b) Those who have constructed/ purchased houses or are residing in their ancestral houses.

c) Terrorist victims/ widows getting subsistence allowance at the rate of Rs. 1000/- per month.

d) Persons whose income exceeds Rs. 1000/- per month from a source what-so-ever.

The rental allowance may be disbursed by the Sub- Divisional Officer (C) concerned through account payee cheques only after satisfying that the head of internal and external migrant family claiming rental allowance is still in occupation of hired accommodation. It may also be ensured that the benefit is given to the genuine persons only.

4. The expenditure involved will be met with from the budget provisions under the head "2235- Social Security and Welfare -60- Other Social Security and Welfare Programme- 116- Other Insurance Schemes- 09- Relief to persons affected by riots- 53- Compensation to persons affected by riots" for the 1994-95. Terrorist victims/ widows getting subsistence allowance at the rate of Rs. 1000/- per month.
