migrants - Resettlement of families in any part
of the State.- Policy thereof.

Sir,

I am directed to draw your attention to Punjab
Government policy letter No.1/6/88/RR-Teh/7874 dated 15.4.1988
on the subject cited wherein it was stipulated that bonafide
and eligible internal migrant families will be entitled for
grant of concessions and facilities consequent upon migration
due to feelings of insecurity from villages to towns or from
one town to another town in the same district or adjoining
districts in the State.

2. It has come to the notice of the State Government
that certain internal migrant families have not found it safe
to resettle in their original or adjoining districts consequent
upon migration due to imminent danger to their lives. After
due consideration, it has been decided to resettle such
hard hit and specially deserving families on merits in ^{the} districts
of their choice in any part of the State with prior approval
of the State Government on the specific recommendation of the
concerned Deputy Commissioners with full justification from
whose jurisdiction the family has migrated.

3. The above instructions may please be brought to the
notice of all concerned officers/officials for careful
compliance in letter and spirit. The receipt of this letter
may please be acknowledged.
