Subject:- Revised scales of relief for the innocent civilians adversely affected as a result of terrorists violence/action by security forces acting in aid of civil power.

Reference is invited to this Department Memo Nos. 8/203/89-RR-2/5971 dated 17-3-1990 and No. 8/69/89-RR-2/10344 dated 7th May, 1990, No. 8/706/90-RR-2/SPL5 dated 18-1-1991, <sup>No.</sup> 1/30/90-RR-I/4895-96 dated 29-5-1991 and <sup>No.</sup> 8/323/91-RR-II/13168 dated 10-12-1991 vide which several relief concessions have been extended to the next of kin/dependents of innocent civilians killed/100% permanently physically disabled and to partially injured and injured by the terrorist security forces acting in aid of civil power. The component of relief mentioned in these letters was not admissible to the next of kin/dependents of innocent civilians killed by security forces/Police accidentally or otherwise for want of identical approach in the Department of Home and Department of Relief and Resettlement.

2. Keeping in view the hardship to the dependents of innocent civilians killed by Security forces accidentally or otherwise, the matter has been examined in detail and it has been decided to extend all the relief/concessions to the next of kin/dependents of innocent civilians killed/100%

permanently disabled and to the partially disabled and injured by security forces in action or otherwise which are presently available to the dependents of those killed and to permanently disabled, partially disabled and to injured by terrorists in accordance with the aforesaid instructions.

4. The fact that the deceased/100% permanently disabled person has been killed/<sup>injured</sup> by security forces while in action or otherwise shall be established through the District Magistrate before the disbursement of relief by the concerned Sub-Divisional Officer (Civil) in pursuance with the instructions issued by the Department of Home Affairs and Justice vide Memo No. 7/54/87-5HIV/3385, dated 23-8-1990.

5. These instructions are effective from 1-12-1991.

6. The expenditure involved will be debited to the head "2235-Social Security and Welfare-60-Other Social Security and Welfare Programme-10-Insurance Scheme-(09)-Relief to persons affected by riots.

7. These instructions may be brought to the notice of all concerned and complied strictly.

8. This issues with the concurrence of the Department of Finance received vide I. D. No. 9/6/91-3526/3585 dated 13-12-1991.
