No. S.O. 247/C.A.2/1899/S.9/2010.—In exercise of the powers conferred by clause (a) of sub-section (1) of section 9 of the Indian Stamp Act, 1899 (Central Act No. 2 of 1899), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to remit the duty, chargeable under the aforesaid Act, with respect to the instruments, specified in Schedule 1-A, appended to the said Act, when executed by or in favour of any person, purchasing land, for setting up a Mega Project, approved by the Empowered Committee.

Explanation.—For the purpose of this notification, Empowered Committee shall mean a Committee, constituted by the State Government for the purpose of considering the desirability of granting concession for setting up mega projects for the development of the State of Punjab.
